This will help students stay up-to-date with industry news, gain hands-on experience, and develop professional connections.

The regulation on the procedure for establishing a dual system of training in professional education of the Republic of Uzbekistan is approved. According to the

regulations, in the implementation of dual education, the Constitution and laws of the Republic of Uzbekistan, decisions of the chambers of the Oliy Majlis of the Republic of Uzbekistan, decrees, decisions and orders of the President of the Republic of Uzbekistan, decisions and orders of the Cabinet of Ministers, other legal documents, does.

Professional educational institutions where dual education is organized are determined by the Ministry of Higher and Secondary Special Education of the Republic of Uzbekistan. The possibilities of educational institutions, where dual education is planned, can be studied with the participation of experts appointed by the Ministry of Higher and Secondary Special Education.

Conclusion: The use of the dual education system is important for familiarizing specialists with practical work, introducing them to innovations in the field, and developing their skills through coordinated training programs.
